Volunteer Agreement

2. If I stop being a volunteer for RMSR for any reason, or upon RMSR's request at any time, I will promptly return all of RMSR's supplies, equipment, records, moneys, and other items in good, clean condition.
3. I assert that I have never been convicted of animal cruelty, neglect or abandonment.
4. I assume the risks of being bitten, scratched, injured, or frightened by the cats and kittens in connection with my volunteer work for RMSR. RMSR is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for RMSR, unless they are the result of RMSR's gross negligence or intentional misconduct. I will indemnify, defend and hold RMSR harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for RMSR, or my breach of RMSR's rules, regulations, policies and programs.
5. I understand and agree that RMSR may refuse volunteer applications for any reason.
6. If I will be sheltering or providing foster care or boarding any of RMSR's animals in my home or business, I consent to allow RMSR to visit my home or business from time to time to observe the cats in their living quarters.
7. I have accurately and truthfully completed this Volunteer Application and Agreement.
8. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon RMSR, me and RMSR's and my respective heirs, successors, assigns, executors, and personal representatives.

MEEZER EXPRESS APPLICATION

Meezer Express Transport System Meezer Express "Rules of the Road"

I agree to the following:

All rescue cats are the sole property of Rocky Mountain Siamese Rescue (RMSR). I agree to hold harmless and indemnify RMSR, their Boards of Directors, their members, officers and agents from all claims, demands, actions, causes of action, or liability of any kind whatsoever arising as a result of or in connection with the transport or other disposition of the above named cat(s).

I also agree to the following terms and conditions:

1. All cats will be confined in a carrier during transport.
2. Cats are not to be left unattended in a vehicle for any length of time during warm or hot weather, and during cool weather for no longer than a ten minute break.
3. If the rescue cat needs to spend the night at a volunteer home, such cat **MUST** be kept isolated from any other animals in the home and permission for this stay must be granted by one of the Directors.
4. While in transport, cats must be provided with an opportunity to have food, fresh water and the use of a kitty litter box every four hours.
5. A written log will be kept during transport, beginning with the first transporter and passing from transporter to transporter, such log to include transporter's name, cat's name, date and time of each departure and arrival, any information deemed pertinent during traveling (cat's behavior, eating habits etc.). A copy of such log will be left with the adoptive family. Additionally, updating the Meezer Rescue Express Coordinator continually throughout the trip via e-mail is requested if at all possible.
6. All cats must be accompanied by a clean bill of health (to include at a minimum a negative FeLV/FIV test) from a certified veterinarian/animal shelter. Such paperwork must transport with the cat. A copy of such bill of health must be mailed to the originating rescue center. If the transporter is picking a cat up from a shelter or vet for the rescue, it is the transporter's responsibility to make sure that they get this paperwork. The cat (s) should NOT be accepted without this paperwork unless the transporter receives approval from the Directors. Transporters should only accept the cat(s) originally agreed upon.
7. Any veterinarian costs arising out of negligence of the transporter will be the sole responsibility of such transporter.
8. If you are going to be 30 minutes or more late than the agreed-upon time to meet the next transporter, you MUST call both the next transporter (if they have a cell phone or contact number) AND the emergency contact for your transport.
9. You must have a reliable source of transportation that is appropriately insured. You also must have a current and valid Drivers License with no outstanding tickets.
